PROPERTY CHANGE INSTRUCTIONS

Article VIII

RESTRICTIONS ON USE

Section 8.12 Architectural Control. No building, landscaping, fence, wall, sign or other structure shall be commenced, erected or maintained upon the Property subsequent to the initial completion by Declarant of the Building and the Common Elements, nor shall any exterior addition to or change or alteration to any Unit or any Common Elements be made, unless and until the plans and specifications showing the nature, kind, shape, height, materials and location of the same shall have been submitted and approved in writing by Declarant (if during the Declarant Control Period) or by the Association (if subsequent to the Declarant Control Period) as to harmony of external design and location in relation to surrounding structures and topography, and which approval may be withheld or conditioned in its sole discretion. In no event shall any Owner alter or remove any column or beam in such Owner's Unit without the prior written approval of Declarant (if during the Declarant Control Period) or the Association (if subsequent to the Declarant Control Period), which approval may be withheld or conditioned in its sole discretion.

Pursuant to the Restrictions on Use as outlined in the Master Deed, those owners desiring to alter any Common Elements and/or Limited Common Elements are required to submit their request in writing **prior** the making the alterations.

The attached form should be properly completed and submitted to the Managing Agent for review by the Board of Directors. **No change will be approved without this form properly filled in and submitted.** Additional forms may be obtained from our Managing Agent's office by calling 864.467.1600.
